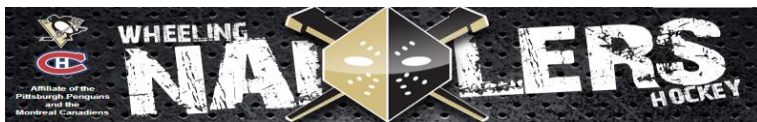

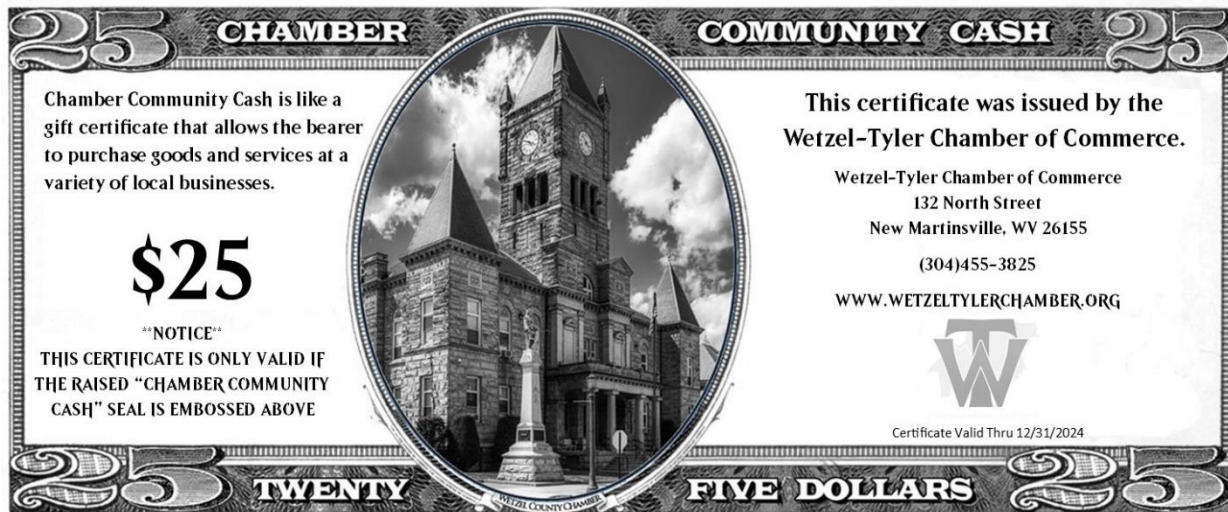
Chamber Community Cash

The Wetzel-Tyler Chamber of Commerce has a program called Chamber Community Cash. This program is designed to help stimulate local shopping with area businesses. Certificate can be used same as cash at any of the participating business locations. Businesses will submit the certificates to chamber for reimbursement less 5%.
